SEFAA Center rentals include multi-purpose space rentals, wet studio rentals, and studio rentals. Individuals and organizations rent the large multi-purpose space at low rates for textile-related meetings, classes, and workshops and they rent our unique, public wet studio for dyeing, felting, surface design, and other wet textile processes. Our two artist's studios are leased on an annual basis and include private entrances, sinks, internet and utilities, and round-the-clock access.

4b (Code:) (Expenses \$ 14,941 including grants of \$ 0) (Revenue \$ 17,554)

Education includes (1) monthly program meetings on a wide variety of textile topic from Electronic Textiles to Sprang: Medieval to Modern, (2) two- to four-hour classes, including Indigo Dye Day, Love Your Blending Board, Kitchen Sink Dyeing, Intro to Tapestry Weaving, and Dye a Rainbow, and (3) one- to five-day workshops including: Map Haiku, Favorite Places, Intro to E-Textiles, Stitched Boxes, Make Your Own Shoes, and Sprang.

Board members voted to approve the return for submission to the IRS via a Google Form which can be accessed at <https://forms.gle/7LZLux2eFJDTkMZe9>.

Form 990, Part VI, Section B, Line 12c - Article 11.6 of the SEFAA Bylaws states: Each director, principal officer, and member of a committee with governing board delegated powers shall annually sign a statement which affirms such a person: 11.6.1 has received a copy of the conflict of interest policy; 11.6.2 has read and understands the policy; 11.6.2 has agreed to comply with the policy; and 11.6.4 understands the corporation is charitable and, in order to maintain its Federal tax exemption, it must engage primarily in activities which accomplish one or more of its tax-exempt purposes. The completed forms are scanned and added to the Board of Directors' Google Team Drive. Hard copies are maintained by the Corporation's Executive Director.

Form 990, Part VI, Section B, Line 15 - Article 11.5.4.2 of the SEFAA Bylaws states: All members of the board or compensation committee who approve compensation arrangements must not have a conflict of interest with respect to the compensation arrangement as specified in IRS Regulation Section 53.4958-6(c)(ii). Article 11.5.4.3 of the SEFAA Bylaws states: The board or compensation committee shall obtain and rely upon appropriate data as to comparability prior to approving the terms of compensation. Appropriate data is described in 11.5.4.3.1 through 11.5.4.3.5. Article 11.5.4.4 of the SEFAA Bylaws states: The terms of compensation and the basis for approving them shall be recorded in written minutes of the meeting of the board or compensation committee that approved the compensation. The details of the required documentation are specified in 11.5.4.4.1 through 11.5.4.4.7. At this time, SEFAA is a completely volunteer-run organization, so the process described above is not in current use.

Form 990, Part VI, Section C, Line 19 - The SEFAA website (fiberartsalliance.org) has links to the organization's corporation registration, charitable organization registration, IRS determination letter, Bylaws (which contain the conflict of interest policy), annual reports, and Form 990's. The organization's Form 990's are also available at Guidestar.org and by request.

Form 990, Part XI, Line 9 - 2018 donations totaled \$6373. But, a portion of the yarn donated in 2017 was sold for \$2,898. So the change in assets is: \$6373 - 2898 = \$3,475. Additionally, and a \$14.37 Paypal payment from 4/2016 was applied to a 4/2018 rental which increases the change in assets to \$3,489. A rounding error of \$1 reduces the change in assets to \$3,488.
