AN ADDITIONAL 11 TEAMS WERE RE-CERTIFIED, AND 39 POTENTIAL PERSON/DOG TEAMS WERE ASSESSED FOR POSSIBLE ENROLLMENT INTO THE PROGRAM. 28 SERVICE DOG TEAMS ALSO PARTICIPATED IN SPECIAL TRAINING SESSIONS INCLUDING RIDING THE BUS, FLYING WITH YOUR DOG, HOW TO DEAL WITH PEOPLE STARING AT YOUR DOG IN PUBLIC, GROUP WALKS, ETC.
