#### MANDATORY WASTE REMOVAL

Ordinance 11-10 requires all residences in the Village of Grandview to remove solid waste that has been accumulated on any premise at least once weekly. Any licensed waste hauler at the choice of the resident or owner of property may be hired to remove accumulated waste. All leases of property in the Village shall specify, as between the landlord and the tenant, who is responsible for waste removal from the premises. The accumulation of solid waste on a premises is in violation of this ordinance and is declared a nuisance. Any person who is in violation of this ordinance shall be punished by a monetary fine not less than \$100 nor to exceed \$750. Each and every day that a violation continues shall be considered a separate offense.

### PARKING DURING SNOW

ABSOLUTELY NO on street parking when 2" or more of snow is expected.

ALL vehicles will be towed at owners expense.

#### **NEW ORDINANCE**

A new pool ordinance has been passed by the village. If you own a pool, please check with us on the new requirements you will need to ensure your pool is in compliance prior to the pool season.

The Village asks that you control your cats and dogs. There is a leash law on both animals. For more information please come down to the Village Office and look up Ordinances 355; 02-03, 07-01 & 11-02. The fines are \$125 payable to the Village of Grandview and a release fee is charged by the Sangamon County Animal Control, when your animal is picked up by them. Please don't let your animals run free!!

#### **PET COURTESY**

#### NEW LAWS EFFECTIVE JANUARY 1

A statewide ban that prohibits drivers from using all hand-held cell phones on the road. Drivers that do not adhere to the ban, which will go into effect Jan. 1, 2014, will be fined \$75. For every subsequent offense, the fee will increase by \$25 and have a maximum fine of \$150. As previously made into a laws, REMEMBER do not text and drive and NO cell phone usage in ANY school zones.

Starting next year, Illinois law enforcement will not only be ticketing you for failure to wear a seatbelt or illegal use of a cell phone while driving, they'll also be stopping motorists who flick cigarette butts out their windows.

With <u>HB 3243</u> now law, flicking cigarette butts will cost you. A first time conviction is a class B misdemeanor with a fine not exceeding \$1,500. A second conviction is a class A misdemeanor with a fine not exceeding \$1,500.

Third or subsequent convictions will be a class 4 felony, punishable by a fine of \$25,000 and imprisonment not less than one year and not more than three years.

#### SHRIMP - CRAB DIP

2 - 8 ounce chive cheese
