



To: All Food Vendors:

Welcome to the 2018 Codorus Blast; sponsored by the Friends of Codorus State Park. The purpose of FOCSP, a non-profit, charitable organization is to support Codorus State Park. This support includes fund raising, volunteer management, membership support, local business involvement, coordination with other interested park organizations, advice and recommendations to the park management.

Our Mission Statement is as follows: A non-profit, all volunteer operated and staffed group, dedicated to restore, preserve and improve Codorus State Park and its surroundings. Assist in providing recreational and educational opportunities for current and future generations.

Food Vendors:

- a.) Must be in compliance with the PA Dept of Agriculture.
- b.) Must have proof of insurance and be able to provide current certificate of liability.
- c.) In order to comply with the State's "Growing Greener" program no Styrofoam can be used with
- d.) distribution of food.
You may request a specific site; however, final assignments are at the discretion of the event committee.
- e.) Vendors are responsible for all equipment needed for their site such as extension cords, generators, etc.
- f.) Generators cannot exceed 1500 watts and must be "quiet". Booths must be self-contained.
We suggest weighted tent canopies for booths.
- g.) Security will patrol Blast area during the night, however Security and Friends of Codorus State Park are not responsible for any damages/theft.
There will be a 1 booth space limit per vendor. **No Personal vehicles at vendors spot.**
- h.) Participants/vendors are responsible for their own clean-up.
- i.) All trash shall be removed by vendor and taken to the dumpsters located along the tree line.
- j.) Food Vendors will automatically receive (4) *three-day* Blast Vehicle Admission Passes that are good for the
- k.) whole event. Additional Vehicle Admission Passes are available at a cost of \$10.00 each for a *three-day* pass or \$5.00 each for a *single* entry pass. These extra passes are available for purchase and pick up on *June 13, 2018* at the Vendor meeting at 6:00pm located at the Band Shell (Blast Location).
- l.) Vendor Check-in and Set-up: 3pm – 7pm Thursday, June 14, 2018 or 9am-3pm Friday, June 15, 2018. Set-up will not be permitted after 3pm on Friday June 15, 2018. Vendors requiring special time for check-in/set-up should contact: Larry Albright at 717-870-5156. Vendor check-out/tear down: Stands are not to be taken down prior to the closing festival time of 5 pm Sunday, June 17, 2018.
- m.) If you are late in arriving and setting up, you will be assessed a \$50 fine for each hour you are late, which must be paid before you can set up.

By signing and submitting this application the vendor assumes all liability & responsibility for theft, damages, etc. & by signing this document releases Codorus State Park and The Friends of Codorus State Park, its employees & volunteers from any and all liability. I agree to all above state Event Policies & Liability Waivers & Guidelines.

Final paperwork and payment for craft vendors are due by: March 15, 2018. No exceptions will be made.
